#### Commercial Driver's License (CDL) updated requirements

U.S. Department of Transportation Federal Motor Carrier Safety Administration

#### **Entry-Level Driver Training Requirements for CDL Applicants**

The new Entry-Level Driver Training (ELDT) regulations require that all entry-level drivers of commercial motor vehicles (CMVs) receive training from a provider listed on FMCSA's Training Provider Registry.

**Beginning February 7, 2022**, to be eligible to take required skills or knowledge tests, commercial driver's license (CDL) applicants must have completed applicable entry-level driver training from a registered training provider.

Use the scenario chart below to determine if you are required to complete entry-level driver training.

If	Then	
A driver holds a commercial learner's permit (CLP) that was issued before February 7, 2022	The driver is not required to complete entry-level driver training, as long as the driver obtains a CDL before the CLP expires.	
A driver was issued a CDL or an S, P, or H endorsement before February 7, 2022	The driver is not required to complete entry-level driver training for the previously-issued license or endorsement, even if it has since lapsed.	
A driver holds a CLP that was issued before February 7, 2022, but the CLP expires before the driver applies for his or her CDL	training.	
A driver obtains a CLP on or after February 2022		
A driver held a CDL prior to the compliance date, and applies for an upgrade to a higher class of CDL, or an S, P, or H endorsement for the first time on or after February 7, 2022	The driver must complete the required entry-level driver training for the class of CDL to which the driver is upgrading or the endorsement(s) for which the driver is applying.	

#### Who is considered an entry-level driver?

Entry-level CMV operators in interstate and intrastate commerce who are applying to:

- Obtain a Class A or Class B CDL for the first time
- Upgrade an existing Class B CDL to a Class A CDL
- Obtain a school bus (S), passenger (P), or hazardous materials (H) endorsement

The requirements only apply to individuals who obtain a CDL or an S, P, or H endorsement on or after February 7, 2022.

#### Which drivers are not subject to the ELDT requirements?

A CDL applicant with a valid commercial learner's permit (CLP) issued before February 7, 2022, is not subject to the ELDT requirements as long as the applicant obtains a CDL before his or her CLP or renewed CLP expires. This includes CLPs that are renewed after February 7, 2022.

Any individual currently exempt from taking a skills test to obtain a Class A or Class B CDL, or S or P endorsement, is not subject to ELDT requirements.



## **KENTUCKY LECET**Robert Akin, Director

Greetings to my LIUNA Sisters and Brothers. At the present time we are leaving the two-year nightmare of the COVID-19 Pandemic and hopefully

moving forward into a new normal. I pray that COVID has not touched you or your families and that health and prosperity follow you into 2022 and the future.

Since our last newsletter, much has happened in the world of politics in both Washington D.C. and Frankfort that will affect our lives at work and the future of our Union for years to come. For once, the good news is coming from Washington.

The Congress, with much hard work and compromise and the strong support of President Biden, has passed a \$2 trillion dollar Infrastructure Bill. This means \$200 billion annually for 10 years. This means new roads, bridges, tunnels, water sewer projects and all this work is covered by Davis-Bacon rates.

The Congress, again with the full support of President Biden, passed pension relief which will give relief to Multi-Employer Pension Plans such as ours. This will last until 2035 giving each endangered plan the time needed to move into full funding by the time the law expires thus securing a solid fund for your retirement when that time arrives.

Meanwhile in Frankfort, House Bill 4 was passed in both the House

and Senate and promptly vetoed by Governor Beshear. The House then proceeded to override Governor Beshear's veto. So, the next time you file unemployment it will be for only 14 weeks with a benefit reduction as well. Listed below is how the Representatives and Senators voted on HB4. Please do not forget this come November. The Party affiliation next to a Politician's name does not matter. Please stop voting against yourself. Vote for people who will support a working family's agenda and not a conservative social agenda while they pick your pockets.

In this newsletter, as well, are the LIUNA endorsed candidates that we ask you to consider giving your vote to in May and in November. The endorsement and support of political candidates is taken seriously by your leadership at both the Local Union level and at the District Council level. The persons endorsed will work alongside us to help reverse the bad legislation that has hurt us the last 8 years.

As always, keep safety, productivity and brotherhood and sisterhood at the forefront of our movement. Always seek opportunities to take LIUNA Training to improve your viability as an employee. Skills pay Bills!

I would like to close by way of speaking about our District Council President/Business Manager, Mark Isaacs. I have known Mark for over 20 years, both as a leader of this District Council and its Funds, Local 189 Business Manager and a Building Trades Leader. They do not come any better as a man, leader or Administrator. His sole goal had been to improve the status of LIUNA and its members.



We have started on the installation of our new digital LED sign in the front of the union hall. We will use this to inform members and the community of upcoming events at the union hall. The sign will be double sided with a video display. It will have an illuminated cabinet with our name on the top of it. The sign will be about twelve foot tall and eighty four inches wide. We are very excited for this project to be complete!

We have a new contractor at the DOE site, Capital Energy Group. They approached us last summer about wanting to use laborers at the site and sign a contract. After a few months of meetings and negotiations, I am happy to report that Terry and I have a contract with Capital Energy Group. We have several laborers working out there today. They are actually on their second job. If you are reading

this and you would like to work with Capital Energy, here is a list of things you need: OSHA 10 and/or 30, birth certificate and/or passport, driver's license, must be full vaccinations, social security card and ability to pass a drug test and background check.

The Kentucky Lock job was bid this past year and Thalle Construction was awarded the job. Terry and I worked with Thalle and came to an agreement within 45 days. I am pleased to announce that Local 1214 and Thalle, once again, have an agreement to work together. This project is going to last for six to eight years and have a lot of man hours for laborers. There should be two shifts running and I believe they will be working five and six days a week. If you're reading this and you want to work for Thalle, here is a list of things you need to have: a "voided" check OR a letter from your bank with the account information and bank name/address on letter, OSHA 10 and/or 30, social security card, driver's license, and the ability to pass a drug test and background check. Also, there are two videos that have to be watched and a certification can be printed out. The two websites are:

My advice to anyone wanting work at the KY Lock job is to go ahead and watch both videos and get both certifications. Also, make sure that you print off the certification and let us know that you have done this.

Calvert City Super Fund job will hopefully get going later this summer into early fall if everything goes well. This will keep a lot of laborers working. We will know more as time gets closer.

In the 14 years that I have been Business Manager, I have been working with Building and Trades to get on the Labor Standards Committee at the DOE site. We want to have a presence and voice out there. We are not trying to take anyone's work, we just want what is ours. As of March 2022, I was appointed to the committee, along with Kyle Henderson, and we attended our first meeting. I do believe that we will get more work at the DOE site. Laborers will have a voice now and we will get our work.

## HEALTH AND WELFARE FUND Dana Crouch, Administrator

The employees of the Kentucky Laborers District Council Health and Welfare Fund hope that our Laborers and their families are staying safe and healthy in the midst of the continuing COVID-19 pandemic. Please know that we are always happy to assist you with any problems or questions you may have regarding your benefits and eligibility with the Fund.

The following information is in regard to some benefit improvements that have been implemented by the Fund:

The Board of Trustees made the following benefit improvement at their January 2022 meeting:

#### **INCREASE TO ACCIDENT & SICKNESS WEEKLY BENEFIT -- ACTIVE PLAN**

Effective as of February 1, 2022, the Accident & Sickness Weekly Benefit (Loss of Time Disability) will be Increased from \$400 per week / \$57.14 per day for 13 weeks to \$500 per week / \$71.43 per day for 13 weeks. This benefit is subject to federal and state tax. Benefits are paid from the first ( $1^{st}$ ) day of treatment for disability due to accident and the eighth ( $8^{th}$ ) day of treat for disability due to sickness.





In accordance with the Families First Coronavirus Response Act (FFCRA), the following coverage for Over The Counter ("OTC") COVID-19 Tests was implemented:

#### COVERAGE FOR OVER THE COUNTER ("OTC") COVID-19 TESTS

Effective January 15, 2022, the federal government requires that group insurance plans must cover the cost of over -the-counter (OTC) at-home COVID-19 tests at no cost to the Participant. Plans are required to provide coverage for eight (8) tests per month for each participant and dependent per 30-day period (or per calendar month).

The Health & Welfare Fund's Pharmacy Benefit Manager, Elixir, will provide coverage for these tests. Participants can purchase these Tests at Elixir's in-network pharmacies with or without a physician's prescription. If the pharmacy has the ability to process the purchase of the tests through the Elixir system, the Participant and/or Dependent should have no up front cost. If the pharmacy does not have the ability to process the purchase of tests through the Elixir system but is still in-network), the Participant must purchase the tests and then file claim for full reimbursement through Elixir. If the Participant purchases the tests from an out-of-network pharmacy, the Participant must purchase the tests and then file a claim for reimbursement through Elixir which will be capped at \$12 per test.

To file for reimbursement through Elixir, you must file the following information with Elixir:

- 1. Competed Membership Reimbursement Form \*
- 2. Itemized receipt of COVID-19 tests, dated on or after January 15, 2022
- 3. Product name and/or NDC
- 4. Original or photocopy of UPC (Universal Product Code) label of purchased product
- 5. Number of tests purchased for each person

NOTE: If any of the required documentation listed above is not included with your reimbursement request, your claim will be rejected, indicating that additional information is needed.

Allow up to 30 days for claims processing and payment to be issued.
